- All documents or communications concerning the publication or public dissemination of the report entitled A Baseline Evaluation of Cannabis Enforcement Priorities in Oregon, including but not limited to The Oregonian's acquisition of that report as described in the article "Oregon Remains A Top Source For Black Market Pot, State Police Report Says," published in The Oregonian on March 18, 2017, and available at http://www.oregonlive.com/marijuana/index.ssf/2017/03/oregon\_a\_top\_source\_for\_black .html.
- 3. All communications concerning the report entitled *A Baseline Evaluation of Cannabis Enforcement Priorities in Oregon* that were made with anyone who was, at the time of the communication, employed by, an equity holder of, or representing a marijuana business.
