Delta-8 THC



Delta-8 THC is a synthetic cannabinoid derived from the hemp plant and is virtually identical to Delta-9 THC, the psychoactive component of marijuana that produces a "high." Delta-8 carries similar risks including addiction, intoxication, and psychosis but is commercially legal federally and in many states and is sold in candy and vape-form at gas stations, convenience stores, and online.

Self-reported side effects from Delta-8 THC use and intoxication include: psychiatric disorders; respiratory, thoracic and mediastinal disorders; nervous system disorders including anxiety and paranoia (1).

Delta-8 THC products are the result of a loophole in the 2018 Farm Bill




Delta-8 products are on the market as a result of the 2018 Farm Bill that legalized hemp and hemp-derived products. Delta-8 THC products are not extracted from a marijuana plant, but instead are synthetically produced through a chemical process (isomerization) that converts hemp-derived CBD into Delta-8 THC.

Delta-8 THC has been responsible for an uptick in poison control cases

Since January 2021, America's Poison Centers have managed 9,360 Delta-8 THC related exposure cases (6). Nearly half of these cases were accidental exposure to children. One pediatric case was coded with a medical outcome of death (7).

Federal ambiguity has resulted in a patchwork of state laws at various levels of enforcement

Hemp-derived THC products, including Delta-8 THC have been banned in over half of states and are regulated in dozens more. Nearly every state has a different law, but because of the federal loophole, these products are widely available on the internet and are shipped to all 50 states.

In one study, only 14% of Delta-8 THC online sellers had some form of age verification system for purchases. Out of 44 companies, only 5 used an age verification form in compliance with the FDA age requirements and state laws, requiring the customer to upload a photo of a government ID. One other required a signature on delivery of the package. The remaining 38 only had a pop-up asking the user to confirm they are over 18 or 21, with no other controls or verification (3).

Delta-8 is often manufactured in unsanitary conditions with the help of poisonous chemicals (7).
